

Evangelical Lutheran Worship Liturgies License

Revised August 2020

Augsburg Fortress, an imprint of 1517 Media (the Publisher), the publishing house of the Evangelical Lutheran Church in America, as owner and/or administrator of certain rights to the works covered by the terms of this license, grants to the congregation or other qualifying organization identified as the registered owner of this license (the Registered License Owner), the nonexclusive right to reproduce and use the material described below (the Licensed Works) solely in the life and work of the Registered License Owner throughout the terms of this license and subject to the conditions described below.

The following conditions apply:

1. LICENSE ELIGIBILITY

- a. This license is available only to a congregation or other qualifying organization. Licenses are not available for purchase by individuals.
- b. Payment for all license subscriptions must be made on a valid account with 1517 Media.

2. USES AUTHORIZED BY THIS LICENSE

Subject to the terms of this license, the Publisher grants the Registered License Owner nonexclusive permission for the following authorized uses of the Licensed Material:

- a. Reproduction of the unaltered text (only) or of the unaltered text together with the **assembly version** of the music of the Licensed Material in copies (including projected media) intended for use by members of the Registered License Owner or by participants at events sponsored by the Registered License Owner, provided that such copies are for one-time or one-season use at worship or in study.

- c. 3. USES NOT AUTHORIZED BY THIS LICENSE

This license authorizes only the uses described above. All other uses are retained by the Publisher and are subject to separate permission. Examples of such prohibited uses include:

- a. Recordings of the Licensed Material, including the use of commercial recordings or third-party recordings, except as described in 2.c. or as otherwise authorized by law. - f. Reproduction or projection of published musical accompaniments that are not included in the pew or assembly editions.
- g. Translation of the texts of the Licensed Material into any other language.
- h. Posting of Licensed Material on a website, except as provided in 2.c.
- i. Any other use not specifically authorized by this license.

6. EFFECTIVE DATE AND DURATION OF THIS LICENSE

- a. To activate this license, an authorized representative of the applicant must agree to these license terms, apply for the license, and initiate appropriate payment to the Publisher. If the order is placed on the Augsburg Fortress online store, then the authorized representative must check the “I accept these terms” box when placing the license order. Upon receiving application and payment, Augsburg Fortress will issue a license number.
- b. This license is in effect from the invoice date and remains in effect for one year from that date, unless terminated by the Publisher, which may terminate the license at its sole discretion if the Registered License Owner:
 - Does not use the specified copyright acknowledgment and license number;
 - Assigns the license to any individual, congregation, or organization without permission;
 - Does not otherwise comply with the terms of the license.

7. RENEWAL OF THIS LICENSE

- a. At the end of the one-year license term, this license shall automatically renew at the annual rate in effect at the time of the renewal, unless upon receiving the invoice for the next one-year license term, the Registered License Owner terminates the license using the process described on the invoice.
- b. If a license is terminated, either by the Publisher or by the Registered License Owner, you will no longer have permission to use the reprint or recorded material. All resources in print or digital form that were prepared or stored under this license, including archived recordings (podcasts), must be destroyed or disabled.

8. USAGE REPORTS
