**Sharon Betsworth** is the associate professor of New Testament at Oklahoma City University, in Oklahoma City, Oklahoma. She received her Ph.D. from the Graduate Theological Union in Berkeley, California, and is the author of *The Reign of God Is Such as These: A Socio-Literary Analysis of Daughters in the Gospel of Mark* (2010). Betsworth is actively involved with the Society of Biblical Literature's Children in the Biblical World section and is currently working on a book on children in the Gospels and infancy Gospels.

**Jeannine K. Brown** is professor of New Testament at Bethel Seminary in St. Paul, Minnesota. She received her Ph.D. from Luther Seminary in Minnesota; her dissertation on Matthew's disciples was published as *The Disciples in Narrative Perspective*. Her recent works include *Scripture as Communication* (2007) and *Becoming Whole and Holy* (2011; with C. Dahl and W. Corbin Reuschling). Brown has been the regional coordinator of the Society of Biblical Literature for the Upper Midwest Region since 2009.

**Lung-pun Common Chan** is an assistant professor of New Testament at the Chinese University of Hong Kong. Born in Hong Kong, Chan received a Th.D. from the University of Heidelberg, Germany. He is the author of *Eine sozialwissenschaftliche Untersuchung der Metapher des Lammes in der Johannesapokalypse* (forthcoming). His research interests relates particularly to the apocalypses and early Christian texts. Chan is actively involved with the Society of Biblical Literature's Mind, Society, and Tradition section.

**Jonathan A. Draper** is senior professor of New Testament at the School of Theology, University of KwaZulu-Natal, Pietermaritzburg, where he has taught for twenty-five years. He has published numerous articles on the *Didache*, including editing *The Didache in Modern Research* (1996). He is author (with Richard A. Horsley) of *Whoever Hears You Hears Me: Prophets, Performance, and Tradition in Q* (1999) and editor of *The Eye of the Storm: Bishop John William Colenso and the Crisis of Biblical Interpretation* (2003), *Orality, Literacy, and Colonialism in Southern Africa* (2003), and *Orality, Literacy, and Colonialism in Antiquity* (2004). He is also editor of the journal *Neotestamentica*.

**Nicole Wilkinson Duran** is currently the New Testament series editor for the Texts@Contexts series. She is the author of *Having Men for Dinner: Deadly Banquets and Biblical Women* and *The Power of Disorder: Ritual Themes in Mark's Passion Narrative*, as well as various articles on Hebrew Bible and New Testament topics. She served on the editorial board of *The Global Bible Commentary* and has been editor and coeditor of a number of other collections of essays. She is currently an independent scholar outside of Philadelphia.

**James P. Grimshaw** is associate professor of religion at Carroll University in Waukesha, Wisconsin. Grimshaw received his Ph.D. from Vanderbilt University in 2005. **Gerald West** is professor of Old Testament and African biblical hermeneutics in the School of Religion, Philosophy, and Classics at the University of KwaZulu-Natal, South Africa. He is the coordinator of the Contextual Bible Study programme of the Ujamaa Centre, and has written extensively on the collaboration between socially engaged biblical scholars and ordinary readers of the Bible in contexts of struggle for social justice.

**John Yieh** is a professor of New Testament at Virginia Theological Seminary in Alexandria, Virginia. Born in Taiwan, Yieh received a Ph.D. in religious studies from Yale University. He is the author of *One Teacher: Jesus' Teaching Role in Matthew's Gospel Report* (2004), *Making Sense of the Sermon on the Mount* (2007), and *Revelation* (with Henry Brinton, 2010). as president of the Mid-Atlantic Regional Society of Biblical Literature, and is currently president of the Ethnic Chinese Biblical Colloquium.

**Sithembiso Zwane** is completing his master's degree in theology in the School of Religion, Philosophy, and Classics at the University of KwaZulu-Natal, South Africa.
